I am fortunate to have a unique career in the accounting and financial services education profession as a teacher, trainer, instructional designer and author, and to be recognized as a leader in the field of education, training and professional development.

I offer four distinct skills and types of experience:

1. **Teaching:** My experience includes secondary (high school); post-secondary (undergraduate and graduate); continuing, professional adult education; and, corporate training. This year I celebrated my 20th year as an adjunct accounting professor with NYU's School of Professional Studies where I teach non-credit courses in the Division of Programs in Business – Finance, Accounting, Law and Taxation and credit courses in the Division of Applied Undergraduate Studies. I also serve as the Division's Academic Community of Practice (ACP) Leader and am an adjunct professor at Baruch College. Previously served as a full-time Accounting Instructor In-Residence and adjunct professor for the University of Connecticut.

In addition, I also teach Presentation Skills classes for the accounting firms I have worked for.

2. **Instructional Design:** As the Chief Learning Officer for a major accounting firm and previously as the Director of Learning & Development for another major firm, I have:
 - Implemented all phases of the ADDIE instructional design methodology: analyzing learning needs; designing and developing curriculums and training programs; training subject matter experts to teach, facilitate and manage (classroom) training programs; and, assessing and evaluating teaching and learning by comparing desired learning objectives and outcomes to actual outcomes.
 - Designed and developed firm-wide curriculums for multiple services lines (i.e., audit, tax, accounting, consulting) that form a learning path across all levels in the firm, from “staff to senior manager”. The curriculums offer approximately 1500 hours of training and professional development.
3. **Train-the-Trainer:** As a Chief Learning Officer, and previously as the Director of Learning & Development and the Manager of Academic & Career Development for the American Institute of CPAs, I develop and implement national, local and “experiential” training programs focusing on: Program design and development; Teaching, facilitating, and classroom management; and, Assessing and evaluating teaching and learning.

In addition, I have trained new instructors for NYU SPS Division of Programs in Business (DPB) and as the Academic Community of Practice (ACP) Leader I perform classroom observation of other faculty members.

4. **Author/Developer:** I've created and authored activity-based learning materials for the AICPA (*Takin' Care of Business* Education Handbook, a set of 15 business, accounting and finance lesson plans and activities) and the Connecticut Society of CPAs (*Me, Myself, My Money*, a financial literacy curriculum consisting of 20 lesson plans and activities.)
