WHY BUSINESS?

Choosing your major is a pivotal decision that shapes your academic journey and future prospects. The business major at Rice is the ideal launchpad for aspiring leaders. Our curriculum provides a solid grounding in essential business disciplines, including accounting, finance, marketing, organizational behavior, operations management, strategy, and communication.

What sets our program apart is that, alongside your business major, you'll choose a concentration in either finance or management to deepen your expertise. This focused approach ensures that you are well-prepared for a successful career, making the business major a smart investment in your future.

COURSE REQUIREMENTS FOR COMPLETING A MAJOR IN BUSINESS

Our business major provides you with a robust foundation in leadership and business fundamentals. When you declare a major in business, you must also declare a finance or management concentration, which requires additional advanced courses. Students pursuing the undergraduate degree with a major in business must complete:

- A minimum of 16 courses (48-51 credit hours, depending on course selection) to satisfy major requirements.
- A minimum of 120 hours to satisfy degree requirements.
- A minimum of 11 courses (35-36 credit hours, depending on course selection) taken at the 300-level or above.
- A maximum of 3 courses (9 credit hours) from study abroad or transfer credit.
- Specific course requirements for the finance and management concentrations.
- Because of the common core requirements, students may change their major concentration at any time, even after initially declaring the major. To do so, please contact the Office of the Registrar.

STUDY ABROAD

If you are interested in studying abroad, international experiences are possible for Business students. Early planning and consultation is helpful for fitting an international experience into your degree plan, so we encourage interested students to reach out to department major advisors early to discuss your options. Rice's Study Abroad office (abroad.rice.edu) provides information and support for students exploring the options for study abroad experiences.

TRANSFER CREDITS

Please <u>visit here</u> for Rice's general policies regarding transfer credits. No more than 3 courses of transfer credit (9 credit hours) may apply toward the business major, and transfer credit is granted only for courses equivalent to those currently offered in the major.

COURSE OFFERINGS

Please keep in mind that not all courses in the business major are offered every semester, especially major concentration courses. Please check our website for our current course offerings to plan each semester appropriately.

The business school does offer courses during the summer semester. These course typically include BUSI 305 and BUSI 343. Other courses may be offered during this semester.



FREQUENTLY ASKED QUESTIONS

What is the difference between the BUSI major and BUSI minor?

The business major builds on the minor. The two programs share six required courses but the major has a higher level mathematics and statistics requirement, additional required courses in management accounting and operations management and students complete advanced coursework to earn a concentration in finance or management.

Can I earn a major concentration in both finance and management?

Students cannot earn a major concentration in both finance and management because they are not substantially different degree programs (i.e., as few as only three additional courses). But students are free to take as many courses in their non-major concentration as they want.

Why offer an Undergraduate Business Minor?

The Business Minor complements and adds diversity to the outstanding courses available to Rice undergraduates. Students who are following their passions in the sciences, engineering, or the humanities can also acquire a basic understanding of the fundamentals of business. Moreover, through the Business Minor they can develop their critical thinking and communications skills, both of which will provide value whatever their future education or career goals may be.

Do students need the prerequisites?

Yes. Microeconomics and statistics are required because these courses provide the foundation for many of the concepts developed in the business courses. For a Business Minor, the statistics requirements can be fulfilled by completing STAT 280 or an approved alternative (see below). The economics requirement can be fulfilled by completing ECON 100 at Rice.

Can I take STAT 180/STAT 280 to meet the statistics requirement?

You cannot take STAT 180/STAT 280 to meet the statistics requirement for the business major. This will only meet requirements for the minor.

Which courses are approved alternatives to STAT 280 for the Business Minor?

The following courses are approved: BUSI 395 or STAT 180 or STAT 305 or STAT 310 or STAT 312 or STAT 315 or SOSC 302 or DSCI 301 or ECON 307 or POLI 395 or PSYC 339, plus any courses cross-listed with these courses.
