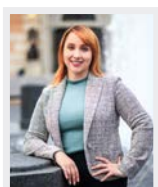

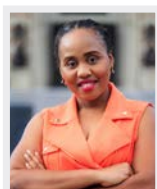

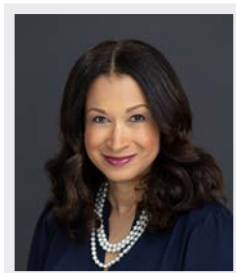
BARBARA BENNETT OSTDIEK – OPENING REMARKS

### **Vice President, Compliance & Ethics, Cheniere**

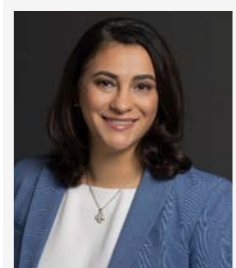

**Operating Partner, Loeb.nyc**

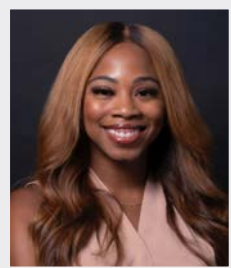
