Founder and Chief Investment Officer, Pickering Energy Partners

Dan Pickering is the chief investment officer at Pickering Energy Partners, a financial services firm focused on investments and advice in the energy sector – covering both traditional oil and gas and energy transition. He currently serves as the portfolio manager of PEP's energy equities strategy and is on the investment committee of PEP's energy co-investment and private equity strategies, assisting in various business development and oversight roles across the firm.

Pickering has spent 30 years as an energy portfolio manager, researcher and analyst. He first served at Fidelity Investments, where he managed approximately \$1 billion of energy sector funds, then at Simmons & Company as head of research. Prior to PEP, he served as the president and founding partner of Tudor, Pickering, Holt & Co. and as chief investment officer of TPH Asset Management.

Pickering is the board chair of Merge Electric Fleet Solutions and also serves on the advisory boards for the Houston CFA Society, Capital Creek Advisors, Dynamo Energy Hub, Midway Companies, as well as the Posse Foundation, the Board of Trustees for Texas Children's Hospital and the Texas Children's Hospital Foundation. He holds a B.S. in Petroleum Engineering from the Missouri School of Science and Technology and an MBA from the University of Chicago.



Zach Davis

Executive Vice President and Chief Financial Officer, Cheniere Energy

Zach Davis has served as the chief financial officer and executive vice president of Cheniere Energy, Inc. (NYSE: LNG) since 2020 and 2022, respectively.

Davis also serves as a board director and chief financial officer of Cheniere Partners GP, the general partner of Cheniere Energy Partners, L.P. (NYSE: CQP). He is responsible for all finance functions of Cheniere, as well as shared services, including information technology, supply chain and communications. Prior to joining Cheniere, Davis held roles in energy investment banking and project finance at Credit Suisse, Marathon Capital and HSH Nordbank (now Hamburg Commercial Bank).

Outside of his role at Cheniere, Davis serves as a board director on Houston's Public Parks Tennis Foundation as well as the Houston 2026 FIFA World Cup Host Committee. He received a B.S. in Economics from Duke University.



Peter Rodriguez – Opening Remarks

Dean and Professor of Strategic Management, Rice Business

Peter Rodriguez is dean of the Jesse H. Jones Graduate School of Business and Virani Undergraduate School of Business at Rice University. He is also an economist and professor of strategic management, and his research interests include corruption, globalization, economic development and social institutions. Rodriguez holds an M.A. and Ph.D. in economics from Princeton University and a B.S. in economics from Texas A&M University. He worked for several years as an associate in the Global Energy Group at JP Morgan Chase, here in Houston and New York. He is presently serving a three-year term on The Federal Reserve Bank of Dallas, Houston Branch board of directors, providing input on regional economic conditions as part of its monetary policy functions. In 2025, Poets&Quants named him their Dean of the Year.



Mark LaCour – Co-host, Live Podcast Recording Co-founder, Oil and Gas Global Network

Mark LaCour is a 25-year veteran of the oil and gas industry who has transformed from field expert to media mogul. After building his career, he launched his own market research firm, earning recognition as an industry insider for unbiased, third-party intelligence.

He then pioneered a media revolution in energy through the Oil and Gas Global Network (OGGN), which he co-founded alongside Paige Wilson. With more than 4 million listeners worldwide, the podcast shares critical industry insights with professionals in various functions and regions. Bairstow earlier led strategic projects and marketing for the Gladstone LNG Project. ConnectGen recently reached a successful exit, selling itself to Repsol. Berry also served as the county administrator for Harris County, the senior-most appointed executive position, where he managed over 4,000 employees and led major reforms of a \$6 billion budget.


